#### **10. General Conditions:**

- Candidates should submit only one application form and not more than one irrespective of number of trade applied for.
- The applicants who have already undergone Apprenticeship training partially / fully for a period of one year or more in any discipline **need not apply.**
- **The applicants found suitable will have to appear for the interview at Kalpakkam, Kancheepuram District, Tamilnadu. Candidates called for the interview, shall meet the related expenses by themselves.**
- The application form should be accompanied by two Conduct Certificates **recently** obtained (within last one year) from 2 Gazetted Officers in Original. The application with one Conduct Certificate will not be entertained.
- Candidates selected for training will not be allowed to withdraw from training except for reasons which are beyond their control. Before commencement of the training, the candidates will have to execute a Contract of Apprenticeship. Those who absent themselves are liable to refund the whole cost of their training as well as the amount received as stipend as determined by the Central Apprenticeship Advisor.
- Every Apprentice who has completed the period of training will have to undergo a test to be conducted by the National council for Training in Vocational Trade to determine his proficiency in the designated trade. Only on passing the test, a Certificate of Proficiency in the trade would be issued by the National Council.
- The Engagement and training are strictly in compliance with the provisions of the Apprentices Act 1961, and **there is no obligation for employment** of the Apprentices on Completion of their training.
- Applications with incomplete particulars or without self attested copies of certificates required or otherwise not in accordance with other requirement of this notice are liable to be rejected.
- **Police Verification Certificate:** Madras Atomic Power Station being highly protected area, Apprentices will be allowed only after submission of Police Verification by Sub Inspector or above of their area. You may take parallel action to obtain the Police Verification Certificate, which is a mandatory requirement, to be produced, upon Selection, prior to joining the training.
