Eligibility

2. Next of Kins (NOKs)/dependents of ASSAM RIFLES personnel who DIED WHILE IN SERVICE OR DISCHARGED FROM SERVICE ON MEDICAL GROUNDS OR MISSING ARE ELIGIBLE FOR COMPASSIONATE GROUND APPOINTMENT.

Applicability

- 3. Compassionate Ground Appointment is applicable as per priority to only **ONE** dependent family member of a Government servant who:-
 - (a) Priority 1. Is killed in action.
 - (b) Priority 2. Dies while in service (including death by suicide).
 - (c) <u>Priority 3</u>. Is retired on medical grounds under Rule 2 of the CCS (Medical Examination) Rules 1957 or the corresponding provision in the Central Civil Service Regulations before attaining the age of 55 years (57 years for erstwhile Group 'D' Govt servants).
 - (d) Priority 4. Is retired on medical grounds under Rule 38 of the CCS (Pension) Rules, 1972 "Invalid pension may be granted if a Govt servant retires from the service on account of any bodily or mentally infirmity which permanently incapacitates him for the service " or the corresponding provision in the Central Civil Service Regulations before attaining the age of 55 years (57 years for erstwhile Group 'D' Govt servants).
 - (e) Priority 5. Is medically boarded out and is unfit for civil employment.
 - (f) <u>Priority 6. Missing Government Servant</u>. Cases of missing Government servants are also covered under the scheme for compassionate Ground appointment, subject to the following conditions:-
 - (i) A request to grant the benefit of compassionate ground appointment can be considered only after a lapse of atleast 02 years from the date from which the Government servant has been missing, provided that:-
 - (aa) An FIR to this effect has been lodged with the Police.
 - (ab) The missing person is not traceable (after police investigation report).
 - (ac) The competent authority feels that the case is genuine.
 - (ii) This benefit will not be applicable to the case of a Government servant:-
 - (aa) who had less than two years to retire on the date from which he has been missing; or
 - (ab) who is suspected to have committed fraud, or suspected to have joined any terrorist organisation or suspected to have gone abroad.
 - (iii) Compassionate ground appointment in the case of a missing Government servant also **would not be a matter of right** as in the case of others and it will be subject to fulfilment of all the conditions, including the availability of vacancy, laid down for such appointment under the scheme;
 - (iv) While considering such a request, the results of the Police investigation will also be taken into account.
 - (v) A decision on any such request for compassionate ground appointment will be taken by this Directorate.

- 4. The following constitute Dependent Family Member:-
 - (a) Spouse, or
 - (b) Married/unmarried Son (including adopted son), or
 - (c) Daughter (including adopted daughter),or
 - (d) Brother or sister in the case of unmarried Govt employee who was wholly dependent on him at the time of death in harness or retirement on medical grounds, as the case may be.

- 6. The physical efficiency test (PET) will be conducted for all trades including General Duty, Technical, Tradesmen , Clerk & Personal Assistant as under:-

 - 05 Km run to qualify within 24 minutes.
 - (b) For Female Candidates 1.6 Km run to qualify within **8.30 minutes**.
- 7. <u>Trade Test (Skill Test)</u>. Trade test (Skill Test) for technical & tradesmen personnel including clerk & personal assistant will be conducted before undergoing Detailed Medical Examination (DME). No marks will be awarded. Candidates will be assessed as Pass or Fail. Candidates who pass the trade test will only be undergone for Detailed Medical Examination.
- 8. <u>Detailed Medical Examination and Review Medical Examination</u>. Detailed medical examination (DME) and review medical examination RME) will be undergone as per guidelines issued by ADG (Medical) CAPF, NSG & AR dt 20 May 2016.
- 9. <u>Written Test</u>. Candidates who are applying under the scheme of **COMPASSIOANTE** GROUND APPOINTMENT will be exempted from WRITTEN EXAM TEST.
- 10. <u>Cut Off Date for Reckoning of Age Limit</u>. Cut off date for calculation of upper age limit will be 05 Feb 2017 for fresh applications.
