INDIAN RECEIVES HONOR-ARY FELLOWSHIP FROM UNI-VERSITY OF CENTRAL LAN-CASHIRE: Indian-origin doctor Shiv Pande on 17 July 2015 received honorary fellowship from the University of Central Lancashire (UCLAN) of the UK for his contribution to the community as a general practitioner and medical educator. Shiv Pande is a dedicated medical practitioner, charity campaigner, accomplished broadcaster and distinguished academic. The honorary fellowship of the UCLAN is a prestigious distinction given to individuals for achieving excellence in one's field of work.

PATA AWARD FOR MUZIRIS PROJECT : Kerala Tourism's Muziris Heritage Project (MHP) on 18 July 2015 bagged the 2015 Pacific Asia Travel Association (PATA) award in the 'Heritage & Culture' category. The award was conferred on the Muziris heritage project for its conservational aspect, uniqueness, and impact on local community. It recognises the projects objective that is, restoring the historical and cultural significance of the ancient town that stretches across North Paravur in Ernakulam to Kodungalloor in Thrissur. Muziris heritage project, the flagship project of the State is one of the biggest heritage conservation projects of modern India.

GRAND PRIX WORLD PRESS
CARTOON 2014 AWARD: Pamarthy Shankar, a cartoonist working with the prominent Telugu Daily newspaper Sakshi, on 11 July 2015 won the Grand Prix World Press Cartoon 2014 Award for sketching Nelson Mandela. He was presented the award at Cascais in Portugal by World Press Cartoon Director Antonio Antunes. A Nelson Mandela caricature drawn by Shankar after the death of the iconic South African anti-apartheid leader in December 2013, fetched him the

award for the year 2014. Shankar's caricature was displayed at a World Press Cartoon exhibition at Cascais in Portugal along with the top 50 works by other cartoonists in 2014.

ROYAL SOCIETY'S COPLEY MEDAL FOR PETER HIGGS : Nobel Prize winner Professor Peter Higgs on 20 July 2015 won the world's oldest scientific prize, the Royal Society's Copley Medal. With this, 86-year old Higgs joined the ranks of Charles Darwin, Albert Einstein and Stephen Hawking. He was awarded the medal for his fundamental contribution to particle physics and his pioneering work on the theory of the Higgs boson that explains the origin of mass in elementary particles. The presence of Higgs boson was confirmed by the experiments at Large Hadron Collider (LHC) in 2012.

FRENCH FILM TO SHOW-CASE ANAND KUMAR'S SUPER 30 : Super 30 initiative of mathematician Anand Kumar was in news in July 2015 as it will now feature in a 90-minute film The Big Day made by famous French director Pascal Plisson. The initiative helps students of deprived section to crack the prestigious IIT entrance examination. Super 30 was started by Kumar along with former Bihar Police director general Abhayanand over a decade ago. It was selected by Time magazine for the list of The Best of Asia 2010.

FUKUOKA ASIAN CULTURE PRIZE 2015 : Historian Ramachandra Guha was on 24 July 2015 chosen for the Fukuoka Asian Culture Prize 2015 in the Academic Category. The prize will be conferred upon him on 17 September 2015 in Fukuoka International Congress Center in Japan, following which the awardees will be deliberating lectures at high-schools and universities across the city. Guha, who is best known for his book India after Gandhi, will speak on Gandhi, India and the World at the event. The aim of his lecture would be to increase awareness of the value of Asian cultures as well as to establish a framework within which Asians can learn from and share with each other.

NELSON ROLIHLAHLA MAN-DELA PRIZE: Helena Ndume of Namibia and Jorge Sampaio of Portugal were on 24 July 2015 awarded with the first-ever Nelson Rolihlahla Mandela Prize by the United Nations (UN) at the UN Headquarters in New York. Ndume, a female ophthalmologist, was awarded for treating blindness and eyerelated illnesses in Namibia and throughout the developing world. While Sampaio, the former president of Portugal from 1996 to 2006 and also the former mayor of Lisbon from 1989 to 1995, was awarded for his contribution to his country for his struggle for the restoration of democracy in Portugal. The award ceremony was a part of the annual commemoration of Nelson Mandela International Day, which is observed on 18 July every year.

TWO INDIANS AMONG RAMON MAGSAYSAY AWARDEES
FOR THE YEAR 2015: The Board
of Trustees of the Ramon Magsaysay Award Foundation (RMAF) on
29 July 2015 announced the Ramon Magsaysay awardees for the

Chaturvedi and Anshu Gupta. The
awards will be presented on 31 August 2015 at Manila, Philippines.

- Sanjiv Chaturvedi, India: He was awarded for Emergent Leadership for his exemplary integrity, courage and tenacity in uncompromisingly exposing and painstakingly investigating corruption in public office.
- Anshu Gupta, India: He was recognized for his creative vision in transforming the culture of giving in India and his enterprising leadership in treating cloth as a sustainable development resource for the poor. He founded Goonj in 1999, which is a non-governmental organisation based in Delhi.
- Kommaly Chanthavong, Laos: She was recognized for her fearless, indomitable spirit to revive and develop the ancient Laotian art of silk

## EXPLANATIONS

- (1) The WTO consisted of 160 members till 26 June 2014. On 26 June 2014, Yemen became the 160th WTO member, closing the 13-year long chapter of negotiating its accessions terms with WTO member countries.
- 2. (4) There is no maximum limit on investment in Kisan Vikas Patra (KVP). KVP certificates are available in denomination of Rs 1,000, Rs 5,000, Rs 10,000 and Rs 50,000. KVP's have a lock-in period of 2 years and 6 months.
- 3. (4) As per a 2014 traffic report, released by the Dubai International Airport in January 2015, for the first time ever, it has overtaken London's Heathrow as the world's busiest airport for international traffic. It reported a total of 70.4 million passengers in 2014 more than the 68.1 million international passengers of Heathrow in 2014.

- 4. (4) Prabhu Nath Dwivedi was, in January 2015, named as the winner of the Sahitya Akademi Award for Sanskrit, 2014. He won the award for his collection of 16 short stories called 'Kanakalochanaha'. He was earlier a professor at Mahatma Gandhi Kashi Vidyapeeth, Varanasi.
- 5. (2) CAFRAL stands for Centre for Advanced Financial Research and Learning. A not-for-profit organisation; it is an independent body fully funded by the Reserve Bank of India. CAFRAL became operational in January 2011 with Usha Thorat as its Director.
- 6. (3) Y. Venugopal Reddy is the Chairman of the 14th Finance Commission of India. He is an Indian Administrative Service officer of the 1964 batch who served as Governor of the Reserve Bank of India (RBI) from 6 September 2003 until 5 September 2008.
- 7. (3) An Inter-Governmental Agreement between Bhutan and India was signed in Thimphu on 22 April 2014. It is related to the development of Joint Venture Hydropower Projects through the Public Sector Undertakings of the two Governments. The agreement provides the framework for implementing four hydro-electric projects (HEPs) totalling 2120 MW.
- 8. (4) The re-launched Kisan Vikas Patra (KVP) will double the principal during its maturity period of 100 months or 8 years and 4 months. Though the investment matures in eight years and four months, one can redeem it after the lock-in period of two years and six months and thereafter in a block of six months by getting a pre-determined maturity value.
